NOREGON ADAPTER STANDARD WARRANTY (1 YEAR)

Pursuant to this warranty, the covered Adapter(s) ("Adapter") is warranted against defects in materials and workmanship to the Adapter for a period of one (1) year from the date of original purchase, or two (2) claims during said time period, whichever event is reached first ("Warranty Period") when used for its intended purpose. Under this warranty, the original Adapter purchaser, and only the original purchaser (the "Purchaser"), may direct its claims to Noregon Systems, LLC ("Noregon") provided such claims arise during the Warranty Period. If a defect arises during the Warranty Period, Noregon, at its option will: (1) repair the Adapter at no charge using new parts or parts that are equivalent to new in performance and reliability or (2) exchange the Adapter with an adapter with equivalent functionality formed from new and/or previously used parts that are equivalent to new in performance and reliability.

This warranty excludes normal depletion of consumable parts and damage or defects resulting from abuse, accident, modifications, or negligence on the part of the Purchaser and/or failure to use the Adapter in accordance with usage instructions. This warranty further excludes damage or defects resulting from: acts of God, and/or unauthorized repairs. Exclusions also include cosmetic defects or damage. This warranty does not cover damage or loss due to the Adapter being stolen, lost, misplaced or used by anyone other than Purchaser.

Noregon will provide ground shipping for the return and/or replacement of the Adapter during the Warranty Period, provided there is coverage. In the event it is determined that the damage or defect is not covered under the Warranty, Purchaser shall be billed for any and all shipping costs.

NOREGON SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, CONSEQUENTIAL, PUNITIVE OR SPECIAL DAMAGES, INCLUDING, BUT NOT LIMITED TO, LOSS OF DATA, LOSS OF PROFIT, LOSS OF REVENUE, OR LOSS OF BUSINESS OR GOODWILL, SUFFERED BY ANY PURCHASER, PERSON OR ENTITY, AND RESULTING FROM THE USE OF THIS ADAPTER, OR ARISING OUT OF ANY BREACH OF THIS WARRANTY. ALL EXPRESS WARRANTIES SPECIFIED ABOVE ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS, IMPLIED OR STATUTORY, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.
